The need for publication:

The Commission, having acknowledged the need to publish a call for invitation to tender on the company's website, also requires the same announcement to be published on the website of an international newspaper/magazine with an editorial focus on economic, commercial, and business issues.

Ad frequency:

Content:

The publication of one (1) call for Invitation for Ofert on the website of an international newspaper/magazine, in the English language.

Maximum limit fund:

€11,500 (eleven thousand five hundred euros)

Confirmations:

Given that the publication will be made in international media and due to the set deadlines, confirmations must be sent to the email address: at emi.aliaj@kesh.al; cc lisarta.nufi@kesh.al.

Furthermore, confirmations must be submitted on the same day via the official email address of the media agency or media outlet. Confirmations not complying with this requirement will be rejected.

Confirmations must be in English.

You are therefore kindly requested to submit your confirmation to our contracting authority.

Required legal documentation (qualification criteria):

1. Document issued by the relevant authority certifying that the operator performs this economic-commercial activity.
2. Document certifying that the economic operator has fulfilled tax obligations for the year 2024.

Selection and evaluation of offers:

Selection of offers will be based on points 7 and 12 of DCM No. 1195, dated 05.08.2008:

Impact factor – 50 points:

The impact factor refers to the extent to which the article/announcement will be accessed by potentially interested parties, based on the circulation and information conveyed by the publication.

Lowest economic offer – 50 points:

The economic offer must be submitted in EURO.

Bidders have the right to participate in the offer evaluation process through authorized representatives.
